1. Irrevocably undertake to provide you with funds sufficient to meet the drawings herein and all your disbursements, commission, charges etc;
2. Agree that all terms set out in the form of agreement and indemnity relating to the issuance of Documentary Credits entered into with you shall be treated as part of this application subject only in case of conflict between the terms herein expressed and the terms set out in such form of Agreement and indemnity that the herein express shall prevail;
3. Agree that you may restrict negotiation under this Documentary Credit to your own offices or to any correspondent of your choice unless otherwise agreed.

The terms used on this application shall have the same meanings as set out in the UCP.
